





Health

The Howard County Health Department and HCPSS School Health Services support your student's academic success by providing vision and hearing screenings at your child's school. These screenings are required by Maryland State Law.

Screenings are provided to the following students:

- Students in Kindergarten, 1st and 8th grades
- All students K-8 new to the state of Maryland that do not have a record of prior vision and hearing screening within the last 12 months
- High School students enrolling in the public school system in the United States for the first time

If your child has glasses, please make sure that he or she wears them on the screening day.

Your child will receive these screenings unless you object for religious reasons. Please send a letter to your child's school health room if you choose to opt out of the Health Department screenings.

If your child does not pass either the vision or hearing screen, you will receive a letter from his or her school notifying you of this result. It is then recommended that you take your child to have his or her vision evaluated by an eye care specialist or that you contact your child's medical provider for a referral to an audiologist for a complete hearing evaluation.

A vision screening does not take the place of a comprehensive eye exam.

HCPSS Supporting our LGBTQIA+ Students

LGBTQIA+ students have long been part of the HCPSS community and informal supports have been in place to support students, their families, their teachers and other school support staff. This year, HCPSS has asked each school to appoint a Rainbow Representative to ensure that each school has an ally and advocates for LGBTQIA+ students, staff, and families. The school Rainbow Representative attends quarterly meetings; receives and disseminates information regarding LGBTQIA+ topics of interest to the school and school community as appropriate; and provides instructional support for educators. Clarksville Elementary Schools Rainbow Representative is Amy Rabinowitz.

The first step in providing information to students are Safe Space Posters. Around our school, you will see some "Safe Space" posters. Sometimes, for a variety of reasons, a person, or certain group of people, might feel unsafe to show their true colors for fear that others might treat them differently, or refer to them in an unkind way. At HCPSS, it is our priority to make sure every student not only *is* safe, but also *feels* safe to be their authentic and true selves. We hope our Safe Space posters serve as a reminder that there is a trusted adult you can go to who is an ally to the LGBTQ+ community, who will affirm a student's chosen name and pronouns, and who will not disclose information to others about identity and orientation if a student shares that information. Teachers who have this poster in their classrooms have declared their space a safe space for ALL students.
